

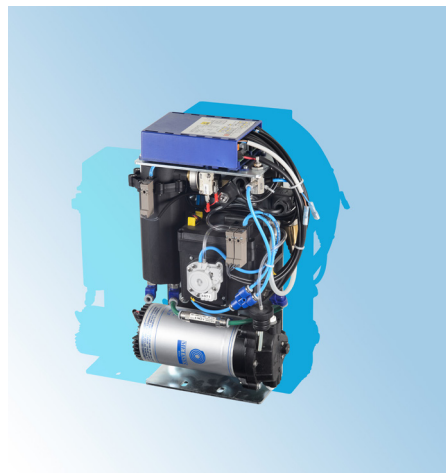

Your rights

If and insofar as the respective legal requirements are met, you shall be entitled to request information from us about personal data or data processing concerning you (Art. 15 GDPR), rectification, erasure and restriction of personal data or data processing concerning you (Art. 16 to 18 GDPR) and transfer of personal data concerning you (Art. 20 GDPR).

Furthermore, if the requirements of Art. 21 GDPR are met, you shall have a right of objection to data processing that relates to a "legitimate interest" of the person responsible pursuant to Art. 6 para. 1 item f) GDPR or that is used for direct advertising.
